PARENTAL INVOLVEMENT

With an estimated expense of \$25,000, the success of the Production lies in the commitment of its performers, designers, directors, board members, and parent and community volunteers. To this end, CTM requires parents of each cast member volunteer a minimum of **4 hours** during pre-production (set painting, set building, parent monitoring, etc.) and for **2 performances** during the course of the show weekend (ticket sales, concessions, green room, etc.).

REHEARSAL ATTENDANCE AND BEHAVIOR

Attendance and appropriate behavior are very important to the production process. If my child is cast in a role in the Production, and chooses to accept that role, I have read the CTM policies regarding rehearsal attendance and behavior, as set forth below:

1. **Conflicts, Absences, and Tardiness:** All conflicts not listed on the Audition Form must be turned in by the first rehearsal. After that time only 3 additional absences will be excused. These excused absences include unforeseen illness, family emergency or a mandatory school function. The Production team reserves the right to re-cast the role of a child who does not follow this policy. Excessive tardiness is considered being 15+ minutes late to more than 3 rehearsals. The Production team reserves the right to re-cast a role of a child who is excessively tardy for rehearsals.
2. **Behavior:** All cast members are expected to act responsibly and to treat others with respect. Bullying will not be tolerated. Those that do not follow these guidelines may face disciplinary action.
